NEW SERVICE CHARGES*

Overhead & Underground

- 1-phase, 2-phase and 3-phase Developments

- 1-phase, 2-phase and 3-phase

Costs for all new services will be based on a 50/50 cost share of estimated costs. Payment due prior to construction.

Non-permanent Service Charges*

Pay 100% of actual costs.

Change Jobs – OH & Underground*

- **Service Upgrade due to Increased Load** - \$650 minimum or 50% of estimated costs, whichever is greater.
- **Aesthetic Reasons** - 100% of estimated cost.

*In all cases, permitting costs, right-of-way clearing, and special construction costs will be billed at cost.
