# **VIBRANT** Dedication reaches new heights

eeker Cooperative welcomed 242 members and guests to celebrate the dedication of VIBRANT Broadband Thursday, September 26 at its headquarters in Litchfield. Special guests included Governor Tim Walz, former Rural Utility Service Administrator Ken Johnson, area legislators and board members.

Following a "flippin good" pancake breakfast served by Chris Cakes and several games of Bingo, the crowd gathered to hear inspiring words from the Co-op's CEO/General Manager Tim Mergen, Ken Johnson and Governor Walz.

Mergen spoke about the similarities of early farmers banding together to bring electricity to the countryside and now, more than 80 years later, the same vision and dedication will bring fiber supported broadband to rural communities. He commended the Board of Directors for taking the risk to undertake the project.

"They're the ones that took the big risk to go ahead and say, 'yeah, let's go ahead and move this project forward," Mergen said. "They did what the Board of Directors did 84 years ago when the Co-op was formed to bring electricity out to the rural area. It was a great big leap of faith then, it is a leap of faith now."

Ken Johnson congratulated the Co-op on all it's done to bring broadband to the rural areas. He expressed how fun it was to come out and see the progress made and how its becoming available to members.

"You are changing the lives of members in the same way electricity did years ago," he said. "In my 40 years of serving rural communities, I have seen what a difference broadband made in the retention of jobs. You are stepping out as a leader in the community."

# **Applications Available for Co-op Board of Director Candidates**

eeker Cooperative, as a member-owned organization, has a board of directors elected by its membership. Directors are elected from each of Meeker's nine districts. In 2020, director elections are scheduled in Districts 1, 2, 5 & 6

# The following townships are included: District 1

· Roseville, Irving in Kandiyohi; Paynesville in Stearns; Union Grove in Meeker.

### **District 2**

· Eden Lake in Stearns; Harvey, Manannah in Meeker.

### **District 5**

·Fairhaven in Stearns; Cokato, Southside, French Lake in Wright; Dassel in Meeker

### **District 6**

· Harrison, Kandiyohi, Gennessee, Fahlun, Lake Elizabeth, E. Lake Lillian in Kandiyohi; Cosmos, Acton, Danielson, Swede Grove in Meeker; Brookfield, Boon Lake in Renville. The District 5 seat is up for election as there had been no candidate for the seat in 2019.

The Board of Directors called for candidates as described in the Bylaws and appointed a member to fill the seat until the next Annual Meeting. That seat will be up for election again in 2022 during its normal rotation.

Any member in the districts identified above that is interested in being placed on the ballot and meets the qualifications identified in the Bylaws must submit a completed Meeker Cooperative Application for Director Form by close of business on November 25, 2019.

All potential candidates must declare their intention to be placed on the ballot by submitting a completed application as described and be declared qualified for placement on the ballot by the Qualifications and Election Committee. No write-in candidates shall be deemed valid.

The Bylaws state that the Board of Directors shall appoint a Qualifications and Election Committee (Q&E Committee) consisting of one Member from each of the Director Districts which is not up for election. It shall be the responsibility of the Q&E Committee to review all applications submitted and to determine that all candidates meet stated qualifications.

The Committee will notify any potential candidate that does not meet the qualifications and allow seven (7) days for the candidate to comply with said requirements. The decisions of the Q&E Committee will be final.

The Committee will have the authority to place qualified candidates on the ballot for election, and for any district in which there is only one candidate, waive the ballot process and declare the candidate elected.

The Qualifications & Election Committee shall prepare and post at the principal office of the Cooperative at least seventy-five (75) days before the meeting the list of qualified candidates for Director elections for each Director District up for election. If no Member from a district up for election is placed on the ballot, said position shall be deemed vacant following the annual meeting and the Board of Directors may appoint a Member from said district to fill said position until the next annual meeting and election of directors.

# **VIBRANT Day**

big thank you to Minnesota Governor Tim Walz and former Rural Utility Services Administrator Ken Johnson for helping with our official Ribbon Cutting and Dedication ceremony for our VIBRANT Broadband project. What a great kick off.

As you can see by the pictures of the event on Pages 1 and 4, both the Governor and the Administrator were game for going up in a bucket truck to light up our VIBRANT sign. I can say with a great deal of certainty that neither the Governor nor the Administrator have participated in a "ribbon cutting" quite so unique; something they will remember for a while.

Each talked about the importance of high-speed internet in today's world and how those without it may be left behind both economically and educationally. I thought one of the more interesting comments was by Mr. Johnson who said they have found the value of a home goes up by about \$4,000 when it is hooked up to high-speed internet.

I'd especially like to thank all the members that stopped by that morning, whether it was just to enjoy the pancakes and sausage for breakfast or to be part or our dedication ceremony. Thank you.

I had several people tell me they were surprised by how close the relationship was between the Co-op bringing electricity to the rural areas 84 years ago and bringing high-speed internet to the rural areas today when others would not. With that thought in mind, following is an excerpt from what I told the gathered crowd which I believe

really illustrates that point.

On August 11, 1938, President Roosevelt was in Barnesville, Georgia. He was there to dedicate the formation of a new electric cooperative. He told the gathered crowd.

"ELECTRICITY is a modern necessity of life and ought to be found in every village, every home, and every farm in every part of the United States."

Now, 81 years later, let's simply insert BROADBAND Internet for the word electricity.

BROADBAND Internet is a modern necessity of life and ought to be found in every village, every home, and every farm in every part of the United Sates.

Remarkable how 81 years later those same exact words he used to describe the need for electricity are holding true, only now for a much different service — high-speed internet.

With Former RUS Administrator Ken Johnson and Minnesota Governor Tim Walz helping with our Ribbon Cutting and Dedication for VIBRANT Broadband, our goal is that a year from now President Roosevelt's 81-year-old statement will read something like this.

Today VIBRANT BROADBAND is a modern necessity of life and is found in every village, every home, and every farm in every part of Meeker Cooperative Light and Power Association's Service area.

During his presentation, Governor Walz commented that while serving as Minnesota Representative in the U.S. Congress he learned that the two most successful programs to ever come out of Washington D.C. was the GI Bill and the creation of the Rural Electrification Administration (REA).

Congress authorized the creation of REA to provide electricity to the millions of rural Americans because the existing for-profit companies did not see that there was enough profit in it for them.

It may seem a bit like deja vu that close to 84 years after Meeker Cooperative Light and Power Association was formed, we are again beginning to deliver another essential service (broadband internet) throughout our rural area because others would not.

### **Belated Happy Birthday**

The following is an excerpt from the minutes of the organizational meeting of Meeker Cooperative Light and Power Association, September 13, 1935:

"It was moved by F. E. Lawrence, and duly seconded by Patrick Flynn that the group proceed to organize a cooperative in this county (Meeker). Motion was unanimously carried. The different features of the charter were discussed by Mr. Ay. The name Meeker Cooperative Light and Power Association was suggested by Magnus Johnson and the suggestion

seconded by Irving J. Clinton. Motion was unanimously carried. The

principal place of business was set as Litchfield."

As the above statement attests to, on September 13th your electric cooperative turned 84 years young. Most of us have never known a world without electricity save for a few short power interruptions. I say hats off to those pioneers who formed Meeker Cooperative that in turn brought us one of the greatest achievements of the past century – Electricity.

### Did You Know -

October is recognized as National Cooperative Month so I thought I'd throw in a bit of information on co-ops per the Cooperative Network.

- There are more than 40,000 cooperative businesses in the United States with 350 million members (many people belong to more than one co-op). These cooperatives generate \$514 billion in revenue and more than \$25 billion in wages, according to a study conducted by the University of Wisconsin Center for Cooperatives, with support from USDA Rural Development.
- Minnesota was the first state to declare an official Co-op Month proclamation in 1948.
- Co-op Month has been a nationally recognized celebration since 1964, when U.S. Secretary of Agriculture Orville Freeman, a former Minnesota governor, proclaimed October Co-op Month.

# Electric cooperatives: Partners in community vitality

lectric cooperatives play an essential role in attracting commercial activity in the areas they serve.

Utility providers are now often looked at by real estate firms and site selection consultants as key partners in moving economic development projects forward. Co-ops are embracing this role by offering a variety of assistance programs to communities working with new and/or expanding businesses to fill their industrial parks and vacant buildings.

The most effective organizations are building in coordination with their local utility providers. Any traditional economic development organization can offer tools to reduce capital costs associated with business expansions, but only electric cooperatives can combine these tools with energy management strategies and other resources that also reduce operating costs, long after the ribbon is cut.

Governor Walz spoke about his vision of bringing accessible broadband to rural communities.

"Rural areas are not failed urban areas," Gov. Walz said. "We have a quality of life that is unparalleled; a work ethic, strong schools, and a desire to be here. The only thing holding us back is connectivity."

"Thank you for your leadership and optimism that is contagious," Walz continued. "I lift you up as a model for the rest of the state."

Walz and Johnson then were fitted with linemen's harnesses and lifted in separate bucket trucks on a bucket truck ride to continue to the "ribbon cutting." On a metal tower alongside the Co-op's headquarters hung a State of Minnesota sign with VIBRANT written across it. The sign was lit up with brilliant green and blue LED lights. The Governor and Johnson each grabbed a cord from the sign and plugged it into a powerstrip, illuminating the sign and receiving applause from the crowd below.

# **VIBRANT Construction going strong**

onstruction on the VIBRANT Broadband system continues strong, with crews installing orange interduct and placing hand holes as far south as the Kandi/Meeker Road near Cosmos and as far northwest as Paynesville. This is all in preparation for blowing fiber cable through the interduct and turning up towers. Expectations are still that these areas will be available for household installations in 2020. If you've seen crews doing installations, perhaps you've wondered what they are doing. Here are a few photos and an explanation so you'll know what you're seeing the next time you come across these activities along the roadway.



Above: Drilling for fiber near Cosmos. There are still many steps that need to happen before people near Cosmos can connect, but construction is right on schedule for 2020 completion.



Left: Placing a "hand hole" in the ground near Paynesville. A hand hole is where fiber strands are spliced, and it allows access for further construction, repair and maintenance of the fiber cables.





Technicians use imaging devices to check the position of the metal pipes used for boring. That sometimes means you're boring along the roadway (right photo) or even through a swampy area (photo on left). Crews are working hard to get as much boring and stringing fiber done before the ground freezes.

# FERC proposes qualifying facility rates under PURPA

he Federal Energy Regulatory Commission (FERC) on Sept. 19 proposed rules that would give states more "flexibility" when implementing the Public Utility Regulatory Policies Act (PURPA), a rule credited with enabling small-scale solar deployment.

The proposed changes would give states authority to let utilities pay qualifying solar facilities varying rates based on market conditions for the live power supplied to the grid, rather than a fixed projected cost. It also lowers the threshold for qualifying facilities (QFs) in regional transmission markets from 20 MW to 1 MW and modifies the "one mile rule," allowing utilities to argue that facilities less than 10 miles apart could constitute a single facility.

Electric utility groups praised the proposed rule, which they said reflected a more modern power market with plenty of cheap natural gas and competitive renewables prices. But renewables groups expressed concern the rule would lessen small solar's ability to compete in the market.

### **Dive Insight:**

States, renewables developers and utilities have awaited changes to the 1978 law that requires utilities to pay QFs for the avoided cost of the power they supply to the electric grid. And FERC Chairman Neil Chatterjee has put reforming PURPA at the top of his priority list since he joined the commission.

"I think renewables can compete in today's energy market without subsidies, without regulations," Chatterjee told reporters after the vote, adding that the law "did its job." Under the proposed rules, states will be able to set prices based on market fluctuations at the time the power is delivered, something solar developers have fought regulators and utilities on in recent months.

"You have no way of predicting what the price is going to be a week from now, [or] a month from now," Eric Lee Christensen, counsel for the plaintiffs in the California case, told Utility Dive at the time.

### Where PURPA now stands

Electric utilities and their representatives praised the rule for its steps to ensure the market remains competitive and prices are kept low.

"By initiating this important NOPR, Chairman Chatterjee has reaffirmed that there are concrete steps FERC can take to better protect electricity customers from unnecessary energy costs and drive additional investments in renewable energy, all while meeting the commission's responsibilities under the Act," Edison Electric Institute President Tom Kuhn said in a statement.

# **Get Your Questions Answered About Cold Weather Shut-Off Protection For Residents and Military Personnel**

What is the Cold Weather Rule?

The Cold Weather Rule protects some members from having their electricity shut off due to non-payment between October 15 and April 15.



### Can my heat be shut off in the winter?

Yes. The Cold Weather Rule

still allows electricity to be shut off for non-payment. You will only be protected if electricity provides your primary source of heat AND you have done all the following things:

- Your household income meets the state guidelines (less than 50 percent of the state median income).
- · You provide Meeker Co-op with a completed Application for Electric Shut-Off Protection; and
- You have a payment arrangement with the Co-op that you have remained reasonably current with.



### What must I do to receive shut-off protection?

If you are behind in your electricity payments and you will not be able to catch up, your first step is to call Meeker Cooperative.

We don't want to shut off anyone's electricity. We will work with you to set up a payment arrangement or help you to see if you qualify for shut-off

protection. There is no way we can know what your financial situation is unless you tell us. At right is a list of providers that can help with your energy bills. It is up to you to contact them for help.



### Will you disconnect me without my knowledge?

No. You will receive a "Notice of Disconnection" in your bill, along with the list of agencies that may help you; a form for you to fill out stating you can't pay; a list of rights and responsibilities for you as well as the Cooperative; and a list of payment plans and other ways to prevent disconnection. If you receive this information, you MUST take the next step and call us or one of the agencies who can help you.

We will not disconnect electricity without first notifying you. We also won't disconnect the electricity on a Friday, a weekend, or the day before a holiday.



### If my electricity has been disconnected, how can I be reconnected?

In order to re-establish power, contact Meeker Cooperative for the total balance due, which may include additional fees and a deposit.

Our members are important to Meeker Cooperative. We would rather work with you to set up a plan to pay your bill than disconnect your service. But everyone who needs help must ask for it by calling (320) 693-3231.



### **Are Military** personnel subject to shut-off?

When a household member has been ordered into active duty, for deployment, or for a change of duty station, some customers may find it hard to pay their utility bills.

Minnesota law protects these military personnel from shut-off if they cannot pay their utility bills in full. For more information or to apply for protection and set up a payment plan, please contact Meeker Cooperative at (320)693-3231.
