VIBRANT HELPS ST. JOHN'S SPREAD THE WORD

A lot can be said about how God brings people together. Many churches today are using technology to reach their parishioners. This used to be in written form with a newsletter and also in recent decades, a website. These worked great, but people become more engaged when there is video.

Pastor David Milz of St. John's Lutheran Church always sought to engage with more people, but it became a critical concern when the pandemic hit. Immediately, he and Diane Harff began to set up video sessions using a phone and notebook computer to record the sermon for the week so they could post it online. But it soon became apparent that their connection to the internet needed to be improved.

Diane is a Meeker Cooperative Light and Power Association member and she had heard about VIBRANT Broadband. She wondered if they could connect to the VIBRANT Fixed Wireless tower near Powder Ridge. When it became apparent that working, learning, and now worshiping from home was becoming necessary, Diane reached out to the VIBRANT Sales Team.

MERGEN'S MESSAGE

FINALLY

On Friday, May 14, Minnesota Governor Tim Walz signed the Executive Order lifting or relaxing Minnesota's face

covering mandate. Finally. Governor Walz instituted the face covering mandate at midnight on July 24, 2020, close to ten months ago. Hopefully we can continue down the road to a full recovery of our normal activities – whatever that new normal might be.

Every Minnesotan has been affected by the COVID-19 Pandemic. Some more than others. At Meeker Co-op we were affected both positively and negatively. On the negative side, we needed to ensure employees had the equipment, materials and resources to work from home, maintain social distancing for those still needing to work in the office, close the office to the public and our members, linemen needed to drive in separate vehicles, and service technicians on both the broadband and electric side needed to get into members homes while ensuring all of the pandemic safety protocols were followed. Lots of additional time, steps and new ways of doing things were developed.

On the positive side, many of the co-ops members received their VIBRANT Broadband just in the nick of time. Unquestionably, we saw a sudden uptick in VIBRANT Broadband installations due to members needing to work from home, schools forced to close and children needing to have solid internet to continue their education.

Remarkably, we saw little variance in late bills or nonpayment compared to past

This was likely due to the numerous assistance programs that were available including Meeker's own Meeker Cares Funding Program. We established this program to help members financially hurt by the pandemic. It was established with funding from a grant from CoBank (one of our lending institutions) Meeker Co-op's Operation Round Up program and the Co-op itself.

ECO PASSES

Minnesota's legislature adjourned on May 17. One of the bills they passed prior to their adjournment was the Energy Conservation and Optimization Act, ECO for short. Co-ops have been working on this piece of legislation for the past four years. It simply is an important update to the Conservation Improvement Program (CIP) legislation which has been in place since 2007.

Much has changed in the way of energy conversation, efficiencies, renewables, new technologies (think electric vehicles and LED lights), and generation of electricity since then and an update was due.

Some of the updates in the new legislation include changing the spending requirement and allowing multi-year plans and measurement of their success over that time rather than annually. This gives utilities across the state more flexibility in the goal to achieve financial savings for their members or customers. Overall, the bill now includes energy efficiency across electric, transportation, agriculture and natural gas sectors.

TREE TRIMMING IMPROVES SERVICE FOR ALL

We are fortunate to have so many trees that offer beauty, shade and a habitat for all sorts of birds and other wildlife. We know that you appreciate our community for many of the same reasons.

At Meeker Cooperative, we strive to balance maintaining beautiful surroundings and ensuring a reliable power supply by keeping power lines clear in rights of way (ROW).

While we recognize and appreciate the beauty of trees, there are three main benefits to tree trimming in ROW areas. However, before touching on the main reasons, we will explain what a "right of way" is and how it may impact you. A right of way is the land we use to construct, maintain, replace or repair underground and overhead power lines. Rights of way enable the Co-op to provide clearance from trees and other obstructions that could hinder the power line installation, maintenance or operation. Meeker Cooperative must be able to maintain the power lines above and below the ROW. Our goal is to provide reliable power to our members while maintaining the beauty of our community.

Safety

First and foremost, we care about our members and put their safety and that of our lineworkers above all else. Overgrown vegetation and trees pose a risk to power lines. If trees are touching power lines in our members' yards, they can pose grave danger to families. Electricity can arc, or jump, from a power line to a nearby conductor like a tree. A proactive approach diminishes the chances of fallen branches or trees during severe weather events that make it more complicated and dangerous for lineworkers to restore power.

Reliability

One of the biggest benefits of a smart vegetation management program is reliability. Strategic tree trimming reduces the frequency of downed lines causing power outages. Generally speaking, healthy trees don't fall on power lines, and clear lines don't cause problems. Proactive trimming and pruning keeps lines clear to promote reliability.

Affordability

As you know, Meeker Cooperative is a not-for-profit cooperative, and that means



we strive to keep our costs in check in order to keep our rates affordable. This extends to our approach to vegetation management. If trees grow too close to power lines, the potential for expensive repairs also increases. Effective tree trimming and other vegetation management efforts keep costs down for everyone.

We appreciate the beauty trees afford, but we also know our community depends on us to provide reliable energy. Through vegetation management, we are better able to keep the power lines clear, prepare for future weather events and secure the reliability of the grid.

ELECTRIC PICKUPS WILL FIND LOTS OF INTERESTED CUSTOMERS

Ford and GMC, as well as Tesla and Rivian, will be coming out with many options to choose from.

According to a survey conducted by Cox Automotive, 40 percent of consumers who plan to purchase a pickup in the next two years would consider an electric version.

Electric pickup shoppers rank price and driving performance high on the list of considerations, while horsepower and brand name are lower on the list. Transporting cargo is also high on the list, however work use is also lower.

Compare that to people who would be buying an internal combustion engine pickup truck who consider horsepower more important on their list. These are interesting and exciting times in the EV world.

"Church members wanted to engage in church services online, especially after the COVID restrictions. The church didn't have a very good Internet connection and uploads were very slow," Diane recalls.

"We had also upgraded our video equipment, and with that we needed to look for a better Internet solution."

Pastor Milz went from recording on a mobile phone to a two-camera system they had purchased from a company that specializes in video equipment for churches.

HOW VIBRANT BROADBAND HELPED

"Before VIBRANT Broadband, when we uploaded our church services, it would take forever or just wouldn't happen. We used to have to drive over to a neighbor's house or someone who got a signal to get it to upload," Diane states. "It was just crazy and nerve-wracking for a while."


VIBRANT Broadband is built on a fiber-fed backbone. This means that our Fixed Wireless service is just as fast as our Fiber-To-The-Premise service. We get asked about how VIBRANT's speed is affected if other users also have our service.

VIBRANT's fiber and fixed wireless services should provide a subscriber with the full speed their package allows. For example, subscribers to our Streaming Package with 50Mbps download and 5Mbps upload will get those full speeds no matter how many households are connected to VIBRANT Broadband.

Where speed is affected is within your household and the number of devices that are connected to your VIBRANT Broadband service.

As you have more and more devices connected, like tablets, computers, televisions, mobile phones, thermostats, smart light bulbs, smart speakers, and more, your speed within your VIBRANT Broadband package can become affected.

INGREDIENTS

coarsely chopped

PRACTICE SAFETY WHEN DIY-ING

Many of us are spending more time at home and finding new, creative ways to enhance our living space. Tackling do-it-yourself (DIY) projects for the home can be fun and cost-effective. But many of these projects do not come without risks. Here are a few safety tips to keep in mind as you get to work.

Select a designated work area. The amount of space you'll need will depend on the

size and scope of your project. Make sure you have adequate lighting and ventilation (if necessary), and the required tools and equipment nearby.

Personal protective equipment (PPE) is

your friend. Stock up on safety goggles, dust masks, ear plugs or noise reduction ear protectors, gloves and any other kind of protection you'll need for your project. Wear appropriate clothing and shoes.

Work slowly and clean as you go. When you rush through a DIY project, you'll likely end up with less desirable results than you intended, or worse, you could make a costly or dangerous mistake. Clean as you go to ensure a safer workspace.

Be cautious with power tools.

Annually, 8% of electrocutions in the U.S. are attributed to improper use of power tools. The Electrical Safety Foundation International offers the following safety tips:

• Use ground fault circuit interrupters (GFCIs)



Tackling a DIY home project is incredibly satisfying, but many of these projects can come with risks. Keep safety in mind as you take on any home improvements.

- Never use power tools near live electrical wires or water pipes
- Use extreme caution when cutting or drilling into walls
- If a power tool trips a safety device while in use, take the tool to an repair center for service
- Do not use power tools without the proper guards #25-08-401
- When using a wet-dry vacuum cleaner or a pressure washer, be sure to follow the manufacturer's instructions to avoid electrical shock.

Remember, you should only tackle DIY home projects within your skill and comfort level. For projects that require extensive electrical work, we strongly recommend you hire a licensed, qualified electrician for assistance.

After seven years of unsuccessful attempts to locate members with outstanding Capital Credit balances, the State of Minnesota allows the Co-op to donate these funds to the Operation Round Up program to use for educational purposes.

YOUR JULY BILL MAY BE HIGHER

With the beginning of Meeker Co-op's summer rate of 12.3¢ per kilowatt hour June 1, the energy you used in June will be at this higher rate. This may result in a slightly higher bill in July. Beginning September 1, the rate will return to the fall/ winter rate of 10.3¢/kWh. If you are on an Energy Management program, your summer rate for your heating/cooling will be 6.2¢/ kWh in the summer and 5.7¢/kWh the remaining months.
