MERGEN'S MESSAGE

THE RISING COST OF GETTING BY

In 1980, the late country music singer Don Williams recorded the song "I Believe in

You." It reached No.1 on Billboard's Hot Country song chart and became Don's biggest record ever. A lyric from that song "the rising cost of getting by" sure seems truer now than ever.

Just as all of you have experienced with higher grocery costs, back to school supplies, clothing, gasoline and every other form of shopping need, the cost of getting by is indeed higher. The same is true for Meeker Cooperative Light and Power Association.

Below are a few examples of some of our regular or more common supplies and materials costs comparing last year versus this year. confined to one or two items or areas of the economy, but across the board.

We are in the middle of establishing our budget for 2023. Management will review it with the Board of Directors at their November meeting. As in past years, board members have one month to review, analyze, and bring back any questions to their December Board meeting. At the December meeting it will be adjusted and refined, if necessary, and approved for management's operating guide for 2023.

As we are still in the middle of formulating the 2023 budget, I can't say for sure, but at this point, I'm believing we will need some sort of rate adjustment in 2023. How much of an increase or how or when it might be implemented is still too early to say. Not good news, and definitely not the way I would like to end the year, but be assured neither I, nor any of the employees or the Board of

On top of these increases, our gasoline costs are up about 13% and diesel fuel costs are up 42%. All of our insurances (health, liability, cyber security, etc.) have gone up significantly over the past several years and, of course, there is wage inflation, too. As we are all aware there are help wanted signs and open positions everywhere, all leading to businesses needing to raise wages or offer a higher starting wage just to hire an employee.

We see increases coming in our biggest annual expense (power supply) as well. Meeker Co-op receives electricity from three different wholesale providers. All three are forecasting wholesale power cost increases for 2023. Just like you see in your household bills, increases are not Directors, enjoy dealing with increasing costs knowing full well at some point they simply must be passed on.

2017 was the last time Meeker Cooperative Light and Power Association had a rate increase. If indeed a rate increase is required in 2023 it will have been five years since the last one. That doesn't make it any easier for the Board of Directors to approve one, the employees to implement it, and you as the member owners to accept it.

On October 13, the Energy Information Administration (EIA) issued a report where they predicted the 2022 residential price of electricity will increase eight percent above the 2021 price. In EIA's Energy Outlook Report, they said the national average residential price of electricity in 2022 will be 14.86 cents per kilowatt hour (kWh). They went on to forecast 2023's average rate to be 15.32 cents per kWh.

Meeker Cooperative is nowhere near that 2022 average price of 14.86 cents per kWh. The Co-op's average single phase General Service rate is 12.3 cents per kWh for the three summer months and 10.3 cents per kWh for the remaining months of the year. This equates to an average annual rate of 10.8 cents per kWh. In addition, the Co-op currently has a Power Cost Adjustment (PCA) of .0078 cents per kWh in place. Adding the PCA charge to the average kWh charge mentioned earlier brings the Co-op's average General Service rate to 11.58 cents per kWh. That is 3.28 cents per kWh under the national average. This is definitely a case where it pays to be below average!

Along with all the rising prices is the supply chain issue of even being able to get the materials and supplies we need, but that is a topic for another time. We will keep you posted as the budget is finalized and we get a better handle on exactly where the Co-op's financials lie for 2023.

MEEKER CO-OP WILL RETIRE \$1,043,807 IN **CAPITAL CREDITS**

The Meeker Cooperative Board of Directors approved the general retirement of \$1,043,807 in capital credits. This includes the amounts paid to estates and former members in 2022 and members who received electricity from the Co-op in 1995, along with power supplier capital credits from 1991-1994. In the past 20 years, Meeker Co-op has retired over \$15.8 million.

As a non-profit cooperative owned by its members, any revenues received from the membership that are in excess of the cost of providing electricity are called margins. These margins allow the Co-op to finance operations such as repairing and maintaining infrastructure. As a cooperative, these margins (often called capital credits) are paid back to the membership as determined by the Board of Directors as the financial condition of the Co-op allows.

If you are a current member and qualify to receive capital credits, you will see a credit on the electric bill you receive in December. Former members will receive a check for their share of capital credits in December as well. Checks are issued once a member's capital credit retired amount totals a minimum of \$25. If a former member's capital credits do not reach the minimum amount of \$25, the Co-op retains them until a future year when the minimum is reached and then they are paid out.

Every year we have members who have moved off our lines and left no forwarding address with the Co-op. When it's time to return capital credits to these members, we often have trouble locating them.

To check for names you may know, go to *www.meeker.coop/capital-credits*. There you will find the link "Unclaimed Capital Credits." Click on that link to download a PDF of the list.

We continue to try to locate these members for seven years, after which the law allows us to donate their capital credits to the Operation Round Up[®] program to provide scholarships for educational purposes. #17-30-302

If you received a payout for the general retirement funds of 1991-1994 or 1995, or because you are no longer a member in 2022, you also have the option to donate these funds to Operation Round Up if you wish to do so.

If you recognize any of the names on the "Unclaimed Capital Credits" list and can provide us with a current address, or if you would like to donate all or a portion of your capital credit payout to Operation Round Up, please contact Jammie at 320-693-3231.

Receiving capital credits is one of the many advantages of being a rural electric cooperative member/owner.

Electric Operations

General maintenance takes up a lot of the linemen's time. The linemen and contractors have also been busy completing workplan projects including upgrading over 7 miles of distribution lines. To-date, 5 miles have been completed, and the last 2 miles are expected to be completed by year-end.

Over 35 new services have been installed since the beginning of the year. Pole inspection and maintenance is ongoing. As a result of these inspections, 90 utility poles were replaced.

Meeker has been working to replace all porcelain cutouts on the system with polymer cutouts. The cutout is what holds a line fuse in place. History has shown porcelain cutouts to be susceptible to breakage under various weather conditions. With Polymer cutouts better performance, it will help to harden our system to reduce outages. This multi-year project has been completed one year early.

Two road jobs required poles to be moved as the county chose to improve and to widen these roads putting our old poles in the road right-of-way and creating a need for us to move them.

Energy Management

Our energy management programs continue to be popular with our members. These programs offer savings on space cooling, space heating, water heating, interruptible crop irrigation, and electric vehicle (EV) charging.

Don't forget to take advantage of the rebate programs that are available including upgrading to a high-efficiency air-source heat pump or upgrading your electric water heater. As EVs gain popularity, the Co-op also offers a \$500 rebate when you install a Level-2 EV charger and sign up for our Charge EV energy management program.

SALES TAX EXEMPTION FOR **ELECTRIC HEATING**

You may be exempt from state and local sales tax for your electricity during the heating season if your primary residential heat source is electricity. If more than 50% of the main heat source for a residence comes from purchased electricity, you are exempt from Minnesota and local sales tax during the months of November through April. All electricity used through the same meter, whether for heating purposes or not, is also exempt throughout this six-month period. The sales tax exemption form can be found online at meeker.coop/ download-forms, or call 320-693-3231 to have a paper copy sent to you. We are updating our records so please submit a form even if you had previously done so. If you have changed your method of heating since filling out the form, please let us know.

STATEMENT OF NONDISCRIMINATION

Meeker Cooperative is pleased to make available a \$1,000 college scholarship funded by Basin Electric Power Cooperative, one Meeker's power suppliers. To be eligible a student must:

Congratulations to **Shelley Carter** for submitting this issue's winning recipe for Leftover Turkey.

- 2/3 cup uncooked wild rice
 - 2 cups water
- 6 tablespoons butter
- ¼ cup finely chopped onion
- ¼ cup finely chopped celery
- 1/3 cup all-purpose flour
- 4 cups turkey broth
- 1/3 cup shredded carrot
- 2 cups chopped cooked turkey
- ½ teaspoon kosher salt, or to taste
 ½ teaspoon ground black pepper, or to taste
- ¼ cup silvered almonds
- ½ teaspoon lemon juice
- ¾ cup half and half cream

 Bring wild rice and water to a boil in a saucepan. Reduce heat to medium-low, cover and simmer until rice is tender but not mushy, 40 to 45 minutes. Drain excess liquid, fluff rice with a fork, and cook uncovered 5 minutes more. Set the cooked rice aside.

- 2. Melt butter in a soup pot over medium heat. Cook and the stir the onion and celery until the onion is translucent, about 5 minutes. Stir in the flour, and cook until it turns a pale yellowish-brown color, 3 to 5 minutes. Gradually whisk in the turkey stock until no lumps of flour remain. Stir in carrot. Bring mixture to a simmer and cook, whisking constantly until the stock is thick and smooth and the carrot is tender, about 2 more minutes.
- 3. Stir in wild rice, turkey, salt, pepper and almonds. Return to a simmer and cook 2 more minutes to heat the ingredients. Stir in the lemon juice and half and half, bring the soup almost to a boil and serve hot.
