Ken Renner's Story:

Connecting Energy and Technology at Meeker Cooperative

rom climbing power poles to overseeing cuttingedge technology, Ken Renner's career has come full circle in a remarkable journey of growth and innovation. As the Director of Technology at STAR Energy, partially owned by Meeker Cooperative, Ken's story serves as an inspiring testament to the symbiotic relationship between the energy industry and technological advancements.

Ken's journey began in 1988 when he joined Meeker Cooperative as an apprentice lineman. Drawn by the allure of outdoor work and the physical challenges of electrical linework, Ken quickly established himself in the field. However, his fascination with technology started to take root around 1999. Recognizing the need for a more technical role within the electrical industry to save his body from the physically demanding work of a lineman, Ken embarked on a path of continuous learning. Balancing his lineman duties with night school, he focused on information technology and software development.

In 2005, armed with a software development degree, Renner took a leap into the world of programming as STAR Energy's first software developer. Leveraging his linework experience, he addressed the industry's needs with practical software solutions. One such solution was the development of PYXIS, an outage notification system.



Driven by his firsthand knowledge of outage restoration and the intricate workings of electrical distribution systems, Renner built a system that not only helps utlities manage outages but provides a platform for exceptional customer service. PYXIS stands apart for its agility and adaptability. Unlike one-size-fits-all solutions, it offers customization, reflecting Renner's commitment to creating user-friendly solutions that benefit everyone, from lineworkers to office personnel.

The seamless adoption of PYXIS at Meeker Cooperative was a natural progression facilitated by Renner's insider perspective and his understanding of the Co-op's operational intricacies, providing the Cooperative with an invaluable tool for streamlined outage management and improved service delivery.



As STAR Energy expanded, so did Renner's role. He managed GIS and software development before rising to the position of Director of Technology. His background in both energy and technology uniquely positioned him to navigate the ever-evolving landscape of cooperative utilities.

But the story doesn't end there. In a full circle moment, as Meeker Cooperative's broadband services began to transform the lives of those in underserved rural areas. Renner himself reaped the benefits.

Prior to the availability of Meeker Cooperative's services, Renner's experience with wireless internet was marked by limitations. Starting with dial-up service and transitioning to wireless providers, he found connectivity lacking and unreliable. The turning point came with the introduction of VIBRANT Broadband. The wireless service, originating from a tower at his home, offered unparalleled quality. 25-21-207 The progress didn't stop there - this summer, VIBRANT further elevated Renner's experience by providing Fiber to the Home. EXPANDING BROADBAND ACCESS

MEEKER COOPERATIVE'S COMMITMENT TO CONNECTIVITY

As we celebrate National Cooperative Month, I wanted to share some exciting updates with you about how Meeker Cooperative is making strides to improve broadband access in our rural Minnesota communities. At the heart of our efforts lies the Cooperative Principles of Concern for Community and Member Involvement. It's my pleasure to provide you with some insight into the recent grants we have received and the significant impact they will have on our region.

We were thrilled to receive a \$19 million grant from the U.S. Department of Agriculture (USDA) as part of the Bipartisan Infrastructure Law. This grant, aptly named USDA ReConnect, will enable us to install and connect approximately 700 homes, businesses, and farms with over 200 miles of fiber optic cable. This expansion will provide high-speed internet and VoIP phone service, positioning our rural communities to thrive in the modern digital age.

In today's world, high-speed internet is no longer a luxury; it's a necessity. The ability to maintain family connections, access telehealth services, engage in remote work, enable precision agriculture, facilitate business operations, and support education all hinge on dependable broadband access to fulfill everyday demands. This expansion not only addresses these critical needs but also nurtures our local economy by attracting businesses and residents, fostering rural development and stability.

When I received news of this grant, I felt a great sense of pride and enthusiasm. Meeker Cooperative has been dedicated to bringing quality broadband to our region since 2018 and this grant allows us to expedite our efforts and fulfill our commitment to our members.

As we look forward to the commencement of the USDA ReConnect project in the summer of 2024, and its anticipated completion by 2026, it's essential to acknowledge the substantial amount of work ahead of us.

The process starts with finalizing the design of the fiber route, which is essential for obtaining the required permits and conducting environmental reviews. Subsequently, the engineering phase ensures the seamless functionality of the entire fiber network once it's interconnected. Upon

reaching this stage, the construction of the primary fiber infrastructure commences. This includes a combination of buried fiber lines and above-ground installation on existing powerlines. Following the installation of the mainline fiber, splicing procedures take place the fiber is extended from the road into homes and businesses. Once this is accomplished, our Installers coordinate with subscribers to establish the connection within their premises.

We are equally as excited to recieve a total of \$4.5 million in grant funds through the Border-to-Border program. This grant program through the Minnesota Department of Employment and Economic Development (DEED) and administered by the Office of Broadband Development (OBD) combines funds from a variety of sources including County and Township ARPA funds.

These grants will bring fiber to the townships of French Lake in Wright County, and Lake Elizabeth, Lake Lillian, and Harrison, all in Kandiyohi County passing 932 homes and businesses. Construction will begin this fall and continue into 2024.

Both the USDA ReConnect and Border-to-Border projects align with our cooperative values of Concern for Community and Member Involvement. These grants focus on underserved areas, where quality broadband is currently lacking. Without the financial support from these grants, it would be challenging for us to bring fiber to these regions.

These grants also offer benefits to our electric system as we move to incorporate additional smart grid technologies, for example electronic system controls to sectionalize lines when a fault occurs. The incorporation of smart devices brings the need to communicate with the devices. Having fiber connected to the devices allows for a stable and efficient means of communication. 30-13-436 The addition of fiber in the electric grid will aid in reducing costs and increase effiencies.

In closing, these grant-funded projects exemplify the Cooperative Difference and the spirit of National Cooperative Month. We are proud to invest in our communities, elevating lives and local economies through enhanced connectivity. Meeker Cooperative remains committed to serving you, our valued members, and creating a brighter digital future for all.

HUNTING ELECTRICAL EQUIPMENT IS NEVER IN SEASON



Whether you are a veteran hunter or trying it for the first time, you must be familiar with hunting safety rules: wearing a bright orange vest, keeping your finger off the trigger until you're ready to shoot, and only pointing at your target.

Along with those safety requirements, be sure to add these electrical safety tips to your list:

- Familiarize yourself with the location of power lines and equipment on land where you shoot.
- Be especially careful in wooded areas where power lines may not be as visible.
- Take notice of warning signs and keep clear of electrical equipment.
- Do not place deer stands on utility poles or climb poles. Energized lines and equipment can conduct electricity to anyone who comes in contact with them.

- Do not place decoys on power lines or other utility equipment. Anything attached to a pole, except for utility equipment, is an obstruction and poses a serious hazard to line crews.
- Never shoot near or toward power lines, power poles, transformers or substations. 23-31-109 A stray bullet could not only damage equipment, potentially interrupting electric service, but could be deadly to the shooter. Damage to the conductor could drop the line to the ground, causing a possibility of electrocution to those nearby.
- Don't make line workers hunt for problems caused in a hunting area; if you cause or simply notice a problem with lines, poles or equipment, let the Co-op know. Sometimes damage isn't noticed for several weeks or months, or unless an outage occurs.



Every year, we see collisions where tractors and other farming equipment accidentally collide with utility poles and power lines, causing injuries and power outages. These dangerous accidents can be avoided by looking up and around your surroundings when operating large farm machinery. If you're preparing for harvest season, please keep the following safety tips in mind:

- Always use a spotter when operating large machinery near power lines.
- Use care when raising augers or the bed of grain trucks.
- Keep equipment at least 10 feet from lines — at all times, in all directions.
- Inspect the height of the farm equipment to determine clearance.
- Always lower extensions to the lowest setting when moving loads.
- If a power line is sagging or low, call us right away.

- Never attempt to move a power line out of the way or raise it for clearance.
- If your equipment does hit a power line, do not leave the cab. Immediately call 9-1-1, warn others to stay away, and wait for the utility crew to cut the power.

Although harvest season is a time filled with tight deadlines and heightened work stress, take the time to consider electrical safety.



Four location numbers are hidden within this Pioneer and four more in articles published on our website between now and the next Pioneer mailing. If you find your number and claim it by calling Meeker Cooperative before October 31, you will have \$10 credit to your account. When you call and verify your information is correct in our system, you will also receive an additional bill credit equal to one month's output from a Member Solar Panel.

MEMBER NOTICE: MINNESOTA COLD WEATHER RULE



The Cold Weather Rule, Section 216B.097 of the Public Utilities Act, in effect from October 1 through April 30 in Minnesota, governs how we handle disconnects; it does not prohibit them. Electric cooperatives cannot disconnect a residential consumer for nonpayment if the disconnection would affect the primary heat source, and all of the following conditions are met:

- You declare the inability to pay by completing the Inability to Pay Form. Household income must include proof of one-month gross total household income or be verified on a form provided either by Meeker Cooperative or by a local energy assistance provider.
- 2. Your household income is at or below 50% of the state median household income and/or you are a recipient of energy assistance for this heating season.
- 3. You must have entered into a payment agreement and remain current under that agreement.

We want to ensure that you are well-informed about your energy payments and the protection offered by the Cold Weather Rule during the winter months. 13-08-432 It's essential to be aware that Meeker Cooperative will be conducting disconnects as per legal requirements, even during the cold weather period.

To ensure transparency and assist you in navigating this process, Meeker Cooperative will provide the following information:

Advance Notice of Disconnection: You will receive a notice of disconnection at least 30 days before any action is taken.

Member Rights and Responsibilities Statement: A document outlining your rights and responsibilities as a member will be provided to you.

Local Energy Assistance Providers: You will be given a list of local energy assistance providers who can offer support in times of financial difficulty.

Cold Weather Rule Protection Request Forms: Forms enabling you to request protection will be available.

Payment Plan Options and Alternatives: Information

about available payment plans and alternative options to maintain uninterrupted service will be presented.

It is crucial for you to take proactive steps to avoid disconnection. We strongly encourage you to act promptly. The sooner you reach out to us, the better your chances of retaining electricity service throughout the winter season.

INGREDIENTS:

COOKIE CRUST:

 Pillsbury or Betty Crocker Sugar Cookie mixture (17.5 oz size)

FROSTING:

- 1 (8 ounce) package of low-fat cream cheese
- 2-3 tablespoons of maple syrup or honey
- 1 tsp of vanilla extract
- Pinch of salt

TOPPINGS:

 Fresh strawberries, blueberries, kiwi, and/or raspberries

DIRECTIONS:

Heat oven to 350 degrees F. Grease either a quarter sheet pan, 9x13 inch baking dish or 12-inch round pizza pan with cooking spray.
