RECONSIDERING MINNESOTA'S NUCLEAR MORATORIUM: A PATH TO A BALANCED ENERGY FUTURE

As Minnesota works toward a cleaner energy future, it's important to evaluate all potential power sources that can provide both reliability and sustainability. As the state moves toward its goal of 100% carbon-free electricity by 2040, discussions about the role of nuclear power have resurfaced.

Currently, Minnesota has a moratorium on constructing new nuclear power plants, a policy that has been in place since 1994. However, with advances in technology and the growing need for reliable, carbon-free energy, it may be time to reconsider this restriction.

A LEGISLATIVE PRIORITY FOR MN'S ENERGY FUTURE

Lawmakers in both the House and Senate are considering bills that would allow for the exploration of new nuclear technologies, including Small Modular Reactors. These discussions are a critical step in determining whether nuclear energy can play a responsible and beneficial role in Minnesota's long-term energy strategy.

State legislators are actively engaging with industry experts, cooperative leaders, and energy stakeholders to evaluate nuclear power's potential contributions to a carbon-free future.

WHY IS NUCLEAR ENERGY PART OF THE DISCUSSION?

Minnesota's commitment to a carbon-free future means reducing reliance on fossil fuels while ensuring a steady, dependable power supply. 08-25-101 While wind and solar energy have made significant contributions to the state's energy mix, these sources are intermittent meaning they only generate electricity when the wind blows or the sun shines.

Nuclear energy, on the other hand, provides consistent and reliable baseload power. Unlike renewables, nuclear plants operate around the clock, helping to stabilize the grid and ensuring that electricity is available when it's needed most. This reliability is especially important in Minnesota, where extreme temperatures place high demands on the energy system.

THE ADVANCEMENTS IN NUCLEAR TECHNOLOGY

In the past, concerns about nuclear energy centered around safety, spent fuel disposal, and high costs. However, advancements in nuclear technology have addressed many of these issues. One of the most promising developments is Small Modular Reactors, a new generation of nuclear reactors designed to be safer, more efficient, and more adaptable to a modern energy grid.

Small Modular Reactors have several advantages:

- **Enhanced Safety** – New reactor designs have built-in safety features that significantly reduce the risk of and potential for accidents.
- **Smaller Footprint** – Small Modular Reactors take up less space than traditional nuclear plants, making them easier to integrate into existing infrastructure.
- **Scalability** – These reactors can be built in stages, allowing utilities to expand capacity as needed.
- **Reduced Waste** – Advances in fuel technology mean that Small Modular Reactors produce less nuclear spent fuel compared to older reactors.

Lifting the moratorium could allow Minnesota to explore these next-generation technologies and work to incorporate them into the state's long-term energy strategy.

BALANCING RELIABILITY AND SUSTAINABILITY

As Minnesota works toward a cleaner energy future, it's important to balance environmental goals with the need for affordability and reliability. Large-scale hydroelectricity and carbon capture have also been proposed as part of the solution, but nuclear energy remains one of the few options that can provide steady, emissions-free power.

Other states and countries are already investing in nuclear as part of their carbon reduction plans. By lifting the moratorium, Minnesota would have the opportunity to study and consider nuclear energy's potential, rather than excluding it outright.

AN OPPORTUNITY FOR THOUGHTFUL DISCUSSION

Lifting the nuclear moratorium does not mean Minnesota will immediately build new nuclear plants. Rather, it opens the door for further study, discussion, and careful planning. At the heart of this conversation is a simple question: How can Minnesota achieve its carbon-free goals while maintaining a reliable and affordable power grid? By keeping all options on the table—including nuclear—we can make informed decisions that benefit all Minnesotans.

Minnesota's energy future will require innovation, collaboration, and careful planning. Revisiting the nuclear moratorium is one step toward ensuring that future generations have access to safe, reliable, affordable and sustainable power.

He represents District 3 and is a self-employed dairy goat farmer producing farmstead cheese. His Co-op involvement includes attending annual meetings, Co-op 101 sessions, the Co-op Tour of Coal Creek, and serving as a trustee for the Meeker Cooperative Electric Trust.

Brad brings an open-minded attitude, strong collaboration skills, and a willingness to listen to new ideas. Outside of Meeker Cooperative, he has been a Compeer Financial member for 27 years. His leadership roles include serving on the Kimball Fire Department for 20 years as treasurer, previously served the Kimball Wrestling Boosters for 10 years as president, and various church leadership positions. He has served on the Meeker Cooperative board since 2012 and has completed the NRECA CCD training program.

He is enrolled in stored water heating, storage heat, peak-shaved water heating, and dual fuel programs. He also utilizes e-billing, ACH automatic payments, and participates in Operation Round Up. Brad believes Cooperative programs serve an essential purpose and should be regularly reviewed.

Brad's short-term goals include providing safe, reliable electricity and ensuring broadband access in rural areas. Long-term, he aims to keep electric rates competitive amid evolving regulations. He supports energy conservation when economically feasible and maintaining a diverse energy portfolio, including coal. He recognizes the potential in battery storage and Meeker Cooperative's leadership in this area.

Brad strongly supports broadband expansion, emphasizing its importance for education, healthcare, and economic development. He identifies government regulations on carbon-free mandates and renewables as the biggest challenge to the Co-op's future. Committed to affordability and reliability, he seeks to contribute to the Cooperative's continued success.

David has extensive board experience, including serving with the International Dairy Deli Bakery Association, the National Restaurant Association, and as a youth sports commissioner. He recently completed the required CCD education courses for Co-op board service and has served as a Meeker Cooperative director for over one year.

David participates in SmartHub, stored water heating, storage heat, peak-shaved water heating, and dual fuel programs. He is a Vibrant Broadband subscriber and an Operation Round Up participant. He believes battery storage could provide backup solutions for peak demand and storms.

His short-term goals include prioritizing safety, maintaining affordable power and internet services, and supporting green energy initiatives. Long-term, he aims to ensure Meeker Cooperative remains transparent and competitive. He supports renewable energy while prioritizing cost-effectiveness and responsible environmental practices.

David sees broadband expansion as critical and identifies inflation and regulatory challenges as top concerns. Having served on the board for 15 months, he values representing Cooperative members and contributing to the Co-op's continued success.

Ben's strengths include his background as a farmer, past Meeker Cooperative director, and education in finance, holding a Bachelor of Science in Finance and an MBA. He is also a member of United Farmers Cooperative, Hutchinson Cooperative, and REI. His leadership experience includes serving on the Hutchinson Chamber of Commerce (currently vice chair and former treasurer), the Rotary Club of Hutchinson (currently treasurer and past president), and the Dassel Development Corporation (currently treasurer).

Ben is enrolled in cycled air conditioning, stored water heating, automatic payment plans, and is a Vibrant Broadband subscriber. His short-term goals focus on providing reliable, low-cost power and supporting economic development. Long-term, he envisions Meeker Cooperative as a leader in Minnesota's power industry while maintaining financial stability.

Ben supports energy efficiency without government mandates. He believes renewables should compete without tax subsidies. He acknowledges the importance of battery storage, transmission line expansion, and distribution line maintenance for reliable electricity. He sees high-speed internet as essential for economic growth and believes Vibrant broadband should be a leader in providing service and do it profitably.

Ben identifies government mandates as the Co-op's biggest challenge. With his background in finance and leadership, he is committed to helping Meeker Cooperative maintain its strong position in the industry.

Jerome's strengths include effective communication, idea-sharing, mechanical aptitude, and a strong work ethic. In addition to his Meeker Cooperative membership, he has been a McLeod Co-op Power member for 44 years and a Hutchinson Co-op Cenex member for 30 years. His leadership experience includes serving on the Brownton School District board for nine years, the Brownton Rod and Gun Club as president for six years, and the Lake Erie Community Association as president for four years. He has served as a Meeker Cooperative director for two months.

He is enrolled in cycled air conditioning, stored water heating, and is a Vibrant Broadband subscriber. Jerome believes the Cooperative's current programs are effective. His short-term goals include managing inflation costs to maintain financial stability, while his long-term focus is leveraging technology to control operating expenses and keep rates affordable.

Jerome supports energy conservation but has concerns about the cost-effectiveness of renewables and recycling challenges for solar panels and wind turbine blades. He sees battery storage as a possible viable way to balance energy supply and costs in the future. On net metering, he believes the Co-op should not pay more than standard supplier rates.

Jerome commends the Co-op's broadband expansion and sees inflation as its biggest challenge. With over 45 years of experience in manufacturing and product development, he is committed to ensuring Meeker Cooperative remains financially stable and innovative.

The first centralized electric power plant, Pearl Street Station, began operation in New York City in 1882, marking a major milestone in modern energy distribution. Developed by Thomas Edison, it supplied electricity to 59 customers, demonstrating the

potential of centralized power generation and paving the way for the development of widespread electric grids.

Meeker Cooperative has available and will provide information to all interested members regarding rates and interconnection requirements. An application for interconnection is required for a Qualifying Facility to interconnect and operate in parallel with the Cooperative’s distribution system and is subject to approval by the Cooperative. INGREDIENTS

- 1# hamburger
- 1 med. onion chopped
- 1 med. green pepper chopped
- 1 11oz can Italian tomato soup
- 1 4.5oz. jar sliced mushrooms (drained)
- 2 c. shredded mozzarella cheese
- 1 32oz. pkg frozen tater tots

DIRECTIONS

In skillet cook first 3 ingredients, drain. Add undiluted soup and mushrooms. Put in a greased 9x13 pan. Top with cheese and tater tots. Bake uncovered at 400 degrees for 30-35 minutes or until golden brown.

Note: If you can't find the soup add 1tsp Italian Seasoning to plain tomato soup.
