Cooperatives around the world operate according to the same set of core principles and values, adopted by the International Cooperative Alliance. These principles are a key reason why America's electric cooperatives operate differently from other electric utilities, putting the needs of our members first.



**1. Voluntary & Open Membership**Membership is open to anyone who can use the co-op's services and accepts the responsibilities,

and accepts the respons without discrimination.



2. Democratic Member Control

Co-ops are run by their members, who set policies and elect leaders. Each member has an equal vote and voice.



3. Members' Economic Participation

Members invest in and control the co-op's capital. Surpluses support growth, reserves, member benefits, or approved community needs.



4. Autonomy & Independence

Co-ops are self-governed organizations. Any outside agreements must preserve democratic control and cooperative identity.



**5. Education, Training & Information** 

Members, leaders, and employees receive education to contribute effectively, while outreach helps the public understand cooperatives.



**6. Cooperation Among Cooperatives** 

Working together across local, regional, and global structures allows co-ops to strengthen services and communities.



7. Concern for Community

Co-ops prioritize the long-term well-being and sustainability of their communities.

# STAY PROTECTED THIS WINTER: KNOW YOUR COLD WEATHER RULE RIGHTS

From October 1 through April 30, Minnesota's Cold Weather Rule helps protect residential members from electric disconnection if loss of service would affect the home's primary heat source. The rule, Section 216B.097 of the Public Utilities Act, guides how disconnects are handled, it does not prohibit them.

To qualify for protection, you must:

- Declare an inability to pay by completing the Inability to Pay Form with proof of one month's household income or verification from a local energy assistance provider.
- Have a household income at or below 50% of the state median and/or be a recipient of energy assistance for the current heating season.
- Enter into and stay current on a payment agreement with Meeker Energy.

Even during winter, disconnects may occur when these conditions are not met. Members will receive:

- Advance notice at least 30 days before disconnection.
- A statement of rights and responsibilities.
- A list of local energy assistance providers.
- Access to Cold Weather Rule forms and payment plan options.

If you're struggling to pay your bill, don't wait. Contact us early to discuss payment arrangements or explore energy assistance programs that can help with heating costs and prevent service interruption.

Staying safe online doesn't have to be complicated or costly. By following a few key habits, you can greatly reduce your risk of cybercrime and protect your personal information, devices, and accounts.

At Meeker Energy and Vibrant Broadband, we encourage members to practice the Core Four from the National Cybersecurity Alliance:

#### 1. STRENGTHEN YOUR PASSWORDS.

Use long, unique, and complex passwords; at least 16 characters that mix letters, numbers, and symbols. Avoid reusing passwords, and consider using a password manager to securely store them.

#### 2. ENABLE MULTIFACTOR AUTHENTICATION (MFA).

MFA adds a second layer of protection beyond your password. It may include a code sent to your phone, a fingerprint scan, or a security key. Always enable MFA on

critical accounts like email, banking, and social media, and never share verification codes.

#### 3. KEEP SOFTWARE UPDATED.

Updates often include security patches that block potential threats. Turn on automatic updates when possible and don't ignore reminders; your phone, computer, and apps all need regular updates to stay secure.

#### 4. WATCH FOR SCAMS AND PHISHING ATTEMPTS.

Be cautious with emails, calls, or texts that create urgency or request personal details. 29-04-412 Avoid clicking suspicious links or downloading unexpected attachments. When in doubt, verify with a trusted source before responding.

Cybersecurity starts with awareness. Small steps, taken consistently, help protect your identity, finances, and peace of mind.

#### FRESH ZUCCHINI RELISH

#### **INGREDIENTS**

- 4 cups diced zucchini
- 1 large onion, thinly sliced
- 2 celery ribs, sliced
- 2 medium carrots, sliced
- 1 medium sweet red pepper, sliced
- 2 Tbsp. salt

- 3/4 cup sugar
- 1/2 cup water
- 1/2 cup cider vinegar
- 1/2 tsp. celery seed
- Dash onion salt
- Dash ground turmeric

#### **DIRECTIONS**

In a large bowl, combine the zucchini, onion, celery, carrots, and red pepper. Sprinkle with salt, cover with cold water, and let stand for 3 hours. Rinse well and drain. In a large saucepan, bring the sugar, water, vinegar, celery seed, onion salt, and turmeric to a boil. Stir in the drained zucchini mixture and return to a boil. Reduce heat and simmer, uncovered, for 5 minutes. Transfer to a large bowl and let cool to room temperature. Cover and refrigerate for at least 2 days before serving.



# ELECTRICAL SAFETY TIPS FOR HUNTERS



At Meeker Energy, your safety is always our priority. Hunting season is a special time of year in Minnesota, and we want to remind everyone to stay alert when enjoying the outdoors. 24-33-302 Electrical equipment can sometimes be hidden by trees, brush, or tall grass, so it is important to keep safety in mind while in the field.

Here are a few key reminders to help you hunt safely:

- **Keep clear of electrical equipment.** Stay away from power lines, poles, substations, and transformers. Damaging this equipment can cause dangerous outages and put lives at risk.
- Do not shoot at or near power lines or insulators. A single stray shot can bring down a line or damage equipment, creating fire hazards or electrical shock risks.
- Know your surroundings. Before setting up a stand or releasing an arrow, look around carefully and identify where electrical equipment is located.
- Be extra cautious in wooded areas. Power lines may be harder to see when leaves and branches conceal them. Always scan the area before aiming or climbing.
- Never place deer stands on utility poles. Poles carry high-voltage lines and are dangerous to climb. They also need to be accessible for our crews in emergencies.
- Never place decoys on power lines or other utility equipment. This can create serious electrical hazards and make it harder for crews to maintain the system.

By keeping these tips in mind, you can enjoy a safe and successful hunting season while helping us keep the power flowing reliably for all members.
